On 15 November 2004, the parties appeared before the Trial Chamber for the Pre-Trial Conference pursuant to Rule 73 *bis* of the Rules of Procedure and Evidence. Following the Pre-Trial Conference, in the afternoon the trial against Fatmir Limaj, Haradin Bala and Isak Musliu commenced. The Prosecution gave its opening statement and on 16 November 2004, the Defence for Fatmir Limaj gave its opening statement. Following the Defence's opening statement, Fatmir Limaj was permitted to address the Court.
